## **NOTE**

The value of the Home Care Package (Package Value) is made up of two parts:

Government Subsidy - paid by the Government Income Tested Care Fee - paid by the Consumer

Each Home Care Package consumer has their financial status assessed by Services Australia (Centrelink) which could be charged by Sequel as an Income Tested Care Fee.

The value of the Home Care Package remains unchanged, whether you are assessed as being required to pay an Income Tested Care Fee or not. If you are assessed as not required to pay any Income Tested Care Fee, the value of 'x' will be zero, hence the total value of your package will be the full amount of the Government Subsidy - as mentioned in the above table.

If, on the other hand you are assessed as being required to pay an Income Tested Care Fee (say \$10 per day), the Government Subsidy will be reduced by \$10 per day, with your contribution of \$10 per day maintaining the value of your package.
